FEARFUL CATASTROPHE AT SEA.

We yesterday announced the loss of the ship, Mamlouk, of New York, on its way to Liverpool, occasioning the destruction of 42 human beings. We are now able to add from the New York papers further particulars of the patastrophe :--The ship sailed from New York, Aug. 9, for Liverpool, with 4 cabin passengers, 36 in the steerage, and a crew of 24 officers and men. She received her first injury on the night of Sunday, August 15, in about latitude 38 N. and longitude 67 W. She was then lying to in a violent hurritime, under the main spencer and fore topmast stay sail. About 10 minutes before 12 o'clock she was struck by a leavy squall, and careened so much that the cargo shifted, and she immediately fell upon her beam ends, the weather nil on the quarter deck being within a few feet of the water. The main and mizen masts were immediately cut away, and the ship righted, but the cargo burst open the hatches and floated about, creating much confusion, and increasing the impending danger. Within a very short time the ressel filled, and she became water-logged, the starboard rail being under water. In this condition the crew and passengers remained until daylight on the next morning, the 16th, when the dreadful truth became apparent to them that out of 64 souls only 22 remained alive, the others havin been washed overboard. The steerage passengers occupied the house on deck, and were in bed at the time of the disster. The heavy sea that struck the ship swept this house overboard with all its inmates, and hence the great lass of that class of passengers, only one of the 36 having hen saved. The cabin passengers were also in bed, and, as | 1 the ship lay on her beam-ends, they were rescued through one of the windows on the weather side. The captain, Chrisfinson, was once washed overboard, but recovered himself

On Wedanday morning, however, the same vessel they had seen on he previous day, the brig Belize, Capt. James H. Dawes, om Boston, bound to Port-au-Prince, was seen bearing down to the wreck, the weather having at this time somewhat moderated. Though the attempt to rescue the surrivers was still attended with some danger, Capt. Dawes and his officers and crew bent themselves nobly to the task, and the twenty-two sufferers were safely conveyed on board the Belize. Their wants were immediately and generously provided for, and the greatest attention paid to their weak and worn-out condition; and the mate in relating the generous conduct of Capt. Dawes, shed tears of gratitude; he aid he never received such treatment. Capt. Dawes changed his course, and brought them all safely to New York, where they arrived on the morning of the 27th of August. The Mamlouk was a new vessel, on her first voyage. She was 50 tons, and owned by Warren Delano, jun., Esq. had a full cargo of flour, provisions, &c., which was worth about 50,000 dollars, and was insured for 81,500 dollars.
